**NOTICE OF INTERVENTION AS A PARTY BY THE BOARD OF TRUSTEES OF  
MIAMI TOWNSHIP, GREENE COUNTY, OHIO**

---

Pursuant to Ohio Revised Code §4906.08 and Ohio Administrative Code §4906-2-12, the Board of Trustees of Miami Township, Greene County, Ohio ("Miami Township Board of Trustees") submits its notice of intervention in the above-referenced proceeding. On April 16, 2021, Kingwood Solar I LLC filed an application with the Ohio Power Siting Board to construct and operate a 175 megawatt solar electric generating facility ("Kingwood Solar Project") to be located in Cedarville, Miami, and Xenia Townships of Greene County, Ohio. The Miami Township Board of Trustees received a service copy of the Kingwood Solar Project Application on or about June 30, 2021.

In accordance with the requirements of Ohio Adm.Code §4906-2-12, the Miami Township Board of Trustees state as follows:

1. The Miami Township Board of Trustees is the duly elected body authorized to act for Miami Township and has taken the required action to intervene, as certified by the resolution attached as **EXHIBIT A** to this Notice.

2. The proposed Kingwood Solar Project will be located partially within Miami Township, Ohio with such area under the jurisdiction of the Miami Township Board of Trustees.
3. The Miami Township Board of Trustees intends to intervene in this case because it has an interest in the proposed project and proceedings as the elected representatives of the citizens of Miami Township, Green County, Ohio who will be impacted by the proposed project.
4. Because the proposed project may have some adverse effect on the roads, properties, and citizens located and/or residing in Miami Township, Green County, Ohio, the Miami Township Board of Trustees has a direct and substantial interest in this proceeding.
5. Miami Township's interests in this case are not and cannot be adequately represented by another party, and the participation of the Miami Township Board of Trustees will contribute to a just and expeditious resolution of this matter and will not unduly delay the proceedings or unjustly prejudice any party.
