Re: PUCO Case No. 18-1314-RR-FED In the Matter of a Request for Upgrades to the Active Warning Devices at the Norfolk Southern Railway Crossing, Lockbourne Road DOT# 513-362E and Fairwood Avenue DOT#513-364T, in Franklin County, Ohio.

On July 9, 2018, the Ohio Rail Development Commission (ORDC) authorized construction for Norfolk Southern (NS) Railway Crossing to upgrade active warning devices at the following locations:

Street	DOT#	County	Project
Lockbourne Road	513-362E	Franklin	Upgrade
Fairwood Avenue	513-364T	Franklin	Upgrade

On September 26, 2019, the Commission issued a Finding and Order approving the project and ordering completion by September 26, 2019. On September 12, 2019, NS requested an extension until January 30, 2020, due to utility conflicts delaying work. On November 21, 2019, the Commission denied this request for an extension.

The crossing project has been completed and is in-service as follows:
