Re: PUCO Case No. 18-1614-RR-FED- In the Matter of a Request for the Installation of Active Warning Devices at CSX Transportation Inc. Grade Crossing, DOT# 155-673S, on CR 270/Dixie Highway in Allen County, Ohio.

On August 28, 2018, the Ohio Rail Development Commission (ORDC) authorized construction for CSX Transportation, Inc. to install active warning devices at the following location:

Street	DOT#	County	Project
Dixie Highway	155-673S	Allen	Lights and Gates

On November 28, 2018, the Commission issued a Finding and Order approving the project and ordering completion by November 28, 2019. On November 25, 2019, and December 19, 2019, CSX filed 30-day extension requests citing material delivery delays and later due to crew leave around the Holidays. The Commission approved the first request on December 16, 2019 but rejected the second request on January 15, 2020.

The crossing project has been completed and is in-service as follows:
