Re: PUCO Case No. 18-267-RR-STP- In the Matter of a Request for the Installation of Active Warning Devices at the Indiana & Ohio Railroad Crossing on Morrow Rossburg Road (DOT#151-316B) in Warren County, Ohio.

On July 30, 2019, the Public Utilities Commission of Ohio (PUCO) authorized construction for Indiana & Ohio Railroad to install active warning devices at the following location:

Street	DOT#	County	Project
Morrow-Rossburg Road	151-316B	Warren	Lights and Gates

On March 14, 2018, the Commission issued a Finding and Order approving the project and ordering completion by March 14, 2019. An extension requested was filed on March 7, 2019, which was granted by the Commission with a new deadline of June 14, 2019 on April 10, 2019. Another extension request was filed on July 14, 2019, with the railroad stating arrangements with an engineering consultant are taking longer than expected. On July 31, 2019, the Commission rejected this extension request, stating this is a safety project, an extension was already granted once, and no good cause exists.

The crossing project has been completed and is in-service as follows:
