Stand Energy Corporation (SEC) is a privately held Kentucky corporation formed in 1984. One of the original three principals continues to work in the day-to-day operation of the company. Prior to forming SEC, Judith A. Phillips (President & CEO), worked for twenty years at Columbia Hydrocarbons. A second founder, Matth. Toebben, continues as Chairman of the Board. SEC initially concentrated on large multi-location industrial customers. Over the years, however,

the focus of operations has changed to small to medium sized commercial, industrial, educational and governmental customers. More recently, SEC has taken part in various choice programs serving small commercial end users and began providing electricity brokering services. In addition to natural gas marketing and electric brokering services, SEC has constructed several LDC by-pass pipelines and builds propane alternate fuel installations for customers interested in receiving interruptible gas service. Stand Energy has been an active participant in the evolution of retail energy deregulation and contracting issues including by regulatory litigation. Stand Energy Corporation has a Wholesale Electric Power Marketing License issued by the Federal Regulatory Commission (FERC) in Case No. 95-ER-362-000 and currently provides retail electric brokering/aggregation service in Ohio (pursuant to Case No. 19-0613-EL-AGG) and provides retail electric broker/aggregation service in Pennslvania, Illinois and is licensed in Virginia as well. Stand Energy does not, at any time, take title to retail electricity.

Stand Energy Corporation is licensed to provide retail electric brokering services in Ohio, Illinois, Pennsylvania and Virginia. Stand Energy Corporation provides natural gas supply service to commercial, industrial, educational and governmental customers in the following states: Illinois, Indiana, Kentucky, Maryland, Michigan, New York, North Carolina, Ohio, Pennsylvania, South Carolina, Tennessee, Virginia, West Virginia and Washington D.C.

Over the years, Stand Energy has had a handful of customer issues that involved the PUCO at any level. Responding to customer inquiries is the responsibility of every single employee of the Company. Stand Energy exists to provide energy commodities and related advice and budgeting services to our commercial, industrial, educational and governmental customers. Stand Energy Corporation currently acts as an electric broker to over 100 commercial and industrial customer locations providing over 75,000,000 kwh behind 10utilities and licensed to provide aggregation/broker services in 4 states. In addition, Stand Energy has over 38 years of experience in the energy supply and marketing industry, has an experienced and dedicated staff for risk management, supply, contract administration, operations, information technology and accounting currently serving hundreds of commercial, industrial, educational and governmental customers in Ohio. Stand Energy has active customer bases behind Ohio electric utilities including Duke Energy, Dayton Power & Light, AEP Ohio Power and First Energy Group.
