## Memorandum: Supplemental Memorandum of I ntervenor Board of County

 Commissioners, Union County, Ohio, Requesting Deferral of Action on Columbia Gas of Ohio, Inc.'s Motion for WaiverNow Comes Intervenor Board of County Commissioners, Union County, Ohio, by David W. Phillips, Prosecuting Attorney in and for Union County, Ohio, through Thayne D. Gray, Assistant Prosecuting Attorney, and supplementing its February 15, 2023, Memorandum Responding to Columbia Gas of Ohio Inc.'s Motion for Waiver, requests the Ohio Power Siting Board defer any decision on the Columbia Gas of Ohio Motion until April 2023.

In the days following filing the Board of County Commissioners Memorandum on February 15, 2023, there have been discussions between principals of these two parties. Those discussions focused on the potential to resolve the limited point of objection by the Board of County Commissioners, i.e., the proposed location of the natural gas pipeline easement across land protected by an Agricultural Easement.

The Board of County Commissioners believes that if this issue can be resolved, it will be resolved by the end of March 2023.

The history of this case shows these parties can work together to avoid the need for contested hearings in this matter. The Board of County Commissioners believes that the suggested time increment for these parties to explore the potential for an agreed recommendation is reasonable and has a reasonable potential to result in an agreed recommendation to the Power Siting Board.

In the interest of efficient use of resources by the parties, the Power Siting Board, and its Staff, the Board of County Commissioners, Union County, Ohio, makes this request that the Power Siting Board defer a decision on the Columbia Gas of Ohio Inc. Motion for a Waiver filed J anuary 24, 2023, until April 2023.
