I. Business Operations:

- The applicant is an energy consulting company providing retail electric and natural gas brokerage services to end user commercial, industrial and residential customers in Texas. Outside Texas, the applicant primarily focuses on commercial and industrial customers.
- The applicant works with customers of all sizes and business types, ranging from retail, manufacturing, property management, religious organizations, government entities and schools. The applicant has expanded operations to most deregulated territories in the United States, acquired licenses as needed.
- In addition to helping customers make informed decisions on their electricity and natural gas procurement, the applicant also offers auxiliary consultant services for power factor correction, recovering utility rebates, lighting retrofitting and more.

II. Proposed Plans for Arranging for Electricity & Gas Services:

The applicant proposes to offer retail electricity and natural gas procurement services. The general process is as follows:

- TES DEFINES THE PROJECT We discuss the customer's specific needs (i.e. start date, contract length, contract language requests like Add/Delete, Move Out language, billing concerns, reducing rate of current contract).
- TES COMPLETES DUE DILIGENCE AND REQUEST PRICING We send the customer the forms that we use with the suppliers in the process. We review a sample of current invoices. We create and send out the bid request including all applicable locations.
- TES RECEIVES BIDS AND MAKE RECOMMENDATIONS We send the customer the best pricing and recommendations for the contract. After discussion, the contract is requested. Because the pricing is based on the market, the turnaround time to return the contract is usually very time sensitive.
- TES PROVIDES FUTURE SUPPORT As the new contract begins, TES will continue to provide assistance for any questions, account changes or billing issues the customer has for the term of the contract. This includes any changes in services, adding locations or resolving billing disputes on behalf of the customer. For commercial rental spaces with tenants, we work with the provider for any ADDS/DELETES or MOVE IN AND OUTS to ensure accuracy and seamless transitions.

III. Payment:

- The applicant will not be paying any utility (i.e., electricity or gas) bills and / or charges for its customers.
 Fees for electricity and gas procurement services will be collected from the Electric or Gas Supplier through a price adder. Customers will pay the supplier directly; the supplier will then remit our fees to us for our aggregated customers.
- Depending on the utility area or supplier providing service, the customer may choose the method to be billed:
 - Supplier Consolidated Billing Option the customer will receive one electricity or gas bill directly from the supplier with whom they have a contract. The supplier has consolidated the charges from the utility into their bill.
 - Utility Consolidated Billing Option the customer will receive one electricity or gas bill directly from the utility. The utility has consolidated the charges from the supplier into their bill. for BOTH supply and distribution services. The customer remits payment for their bill. The utility takes the credit risk and forwards payment to the supplier.
 - Dual Billing Option the customer will receive two bills, one directly from the supplier and one from the utility. The customer is responsible to pay both invoices directly.
- The applicant will not be issuing any bills to customers for its licensed services, and we will not be issuing any bills on behalf of any supplier.
