On January 5, 2007, Applicant was formed as Southwest Energy Partners, LLC, a Texas limited liability company. On January 29, 2009, Applicant amended its name to EMEX, LLC and does business as EMEX Power, LLC and Energy Market Exchange. Applicant has four wholly-owned subsidiaries that are inactive at this time: Bidtron, LLC; Subastas de Energia, S.A de C.V. de R. L. (formed for anticipated operations in Mexico); and EMEX Canada Holdings, LLC, and EMEX Energy Canada, ULC (formed for anticipated operations in Canada).

On May 1, 2018, 02 Investment Partners, LLC made a significant equity investment in EMEX, LLC.

Applicant operates web-based natural gas and electricity brokerage and reverse auction services, allowing commercial and residential customers to compare multiple price offerings from competing suppliers. This platform is a unique business resource that has created unsurpassed transparency and control of customer's costs. Applicant provides multiple products - fixed rates, variable rates and heat rates as well as analysis of market conditions and historical trends.

Applicant's fully automated website and reverse auction platform simplifies the process for customers and provides the ability to easily switch to a lower cost natural gas and/or electricity provider online. Applicant provides all necessary logistics from beginning to end, including credit approvals and customer support throughout the length of a customer's contract.



#### Exhibit B-3 "Disclosure of Liabilities and Investigations"

On October 21, 2010, the Pennsylvania Public Utility Commission ("PA PUC") granted EMEX a License for Electric Generation Supplier as an electricity broker/marketer in docket A-2010-2179537. Subsequently, the PA PUC issued an order cancelling EMEX's electric generation supplier license # A-2010-2179537 on July 16, 2019, for failure to provide proof of financial security (the PA PUC requires all licensed electric generation suppliers to furnish the original bond demonstrating financial security). However, EMEX immediately filed a Petition for Reconsideration of this cancellation based on the fact that the Pennsylvania Public Utility Commission's request for the bond was sent to the wrong regulatory contact, such that EMEX had no actual notice of the request or the pending cancellation. Moreover, the required security bond had been in place continuously with no interruption throughout the time in question. On August 8, 2019, the PA PUC granted EMEX's Petition for Reconsideration, pending review of the merits. This matter was favorably resolved with EMEX being issued a new electric generation license # A-2019-3014305 on December 19, 2019.
