

To Whom It May Concern:

On June 11, 2019, WSP USA (WSP) and American Transmission Systems, Incorporated (ATSI), a FirstEnergy company, received recommendations from the USFWS regarding the proposed Lemoyne-Woodville #2-Fostoria 138 kV Transmission Line Project (Project), referenced as TAILS# 03E15000-2019-TA-1298 (see attached). This document indicated that "Due to the project type, size, location, and the proposed implementation of seasonal tree cutting (clearing of trees ≥3 inches diameter at breast height between October 1 and March 31)," the USFWS did not anticipate impacts to Indiana bat (Myotis sodalis) and northern long-eared bat (Myotis septentrionalis). This correspondence was included with ATSI's pre-construction filing with the Ohio Power Siting Board (OPSB) and the October 1 through March 31 seasonal clearing dates were included as conditions in OPSB's approval. OPSB requires USFWS concurrence for any changes to the Project which would include tree cutting outside of the seasonal clearing dates prior to OPSB approval.

As a result of recent developments and the imminent start to construction, the Project will now require the removal of a limited number of trees and shrubs near approximate coordinate 41.4500, -83.4412 prior to October 1, 2023. This general location is displayed on the attached Proposed Clearing Map. Representative photographs have been included below. Clearing will include approximately five ornamental spruce (*Picea sp.*) trees and four small apple (*Malus domestica*) trees greater than 3" dbh. Due to the small number of trees, their proximity to a well-travelled roadway and residential structures, and the lack of exfoliating bark and cavities, WSP and ATSI do not anticipate impacts to federally protected bat species resulting from the clearing of these trees prior to October 1. In order to gain OPSB approval, WSP and ATSI request USFWS concurrence that clearing of the aforementioned trees prior to October 1 will not result in adverse effects to federally protected bat species.
