Application Experience and Plan Description: Arcadia makes choosing clean energy easy. Arcadia's software manages consumer utility accounts to bundle clean energy, and energy efficiency tools, rate monitoring, and more in a simplified, modern account experience. Founder in 2014, the company's platform now integrates with more than 125 utilities in all 50 States.

Although Arcadia Power, Inc., does not currently offer services in Ohio, we intend to potentially expand our services to include brokerage services for the supply of electricity to retail customers in the coming future. A brief overview of our previous experience in offering to arrange the supply of electricity to retail customers is explained here: As a retail energy broker, Arcadia aims to bring another option to residential customers who may not feel empowered to choose a competitive supplier by themselves. With our energy brokerage service, we will use the agency power the customer provides us, combined with our proprietary technology, to continuously monitor the market for lower-cost competitive energy plans. We will switch the customer once we find a better deal unless they opt-out. This approach gives residential energy consumers an expert advisor who makes taking advantage of a complicated market effortless. Because we are a customer-oriented business, we are well-equipped to handle any customer issue. We have an in-house member experience team that handles all customer inquiries for our solar, wind, and retail energy brokerage products. This team will lead the way in our all-direct dealings with the customer.

Liability and Investigations Disclosures: On September 6, 2019, the Company received a subpoena from the Office of the Attorney General for the State of Illinois (Subpoena). The Subpoena was issued in conjunction with an investigation concerning deceptive marketing practices in the sale of retail electricity supply in the State of Illinois. The Assistant Attorney General who issued the Subpoena (AAG) stated that, they received complaints regarding inperson solicitations by people who identified themselves as representatives of Arcadia Power, Inc. on Scott Air Force Base in the Saint Louis area. The Company disputed the Subpoena because it believed it was issued based upon factual errors as the Company has never performed in-person solicitations in Illinois. On October 11, the Company submitted a sworn statement stating that it had never performed in-person, or any other non-passive marketing, in Illinois. On October 31, the Office of the Attorney General found that the subpoena had been complied with and would require no additional information.



As of 2021, Arcadia Power, Inc. does not currently offer brokerage services for the supply of electricity to retail customers in the State of Ohio. However, we intend to potentially expand our services to include brokerage services for the supply of electricity to retail customers in the coming future. While this is not currently part of our operations, we are taking the necessary steps to remain compliant with the regulatory requirements should we proceed with this endeavor.

Although we do not currently offer services in Ohio, a brief overview of our previous offering for arranging the supply of electricity to retail customers is explained below:

- Customers sign up for Arcadia electric brokerage service through our website www.arcadia.com. The customer pays no fee to sign-up or use the service.
- By signing up, the customer authorizes Arcadia, as their agent, to access their monthly utility bills and to sign the customer to a new supplier plan if the customer approves.
- Arcadia gets regular price quotes from multiple retail energy suppliers. We are agnostic which suppliers we work with as long as they can offer our customers fixed-rate contracts below the customer's current supply option.
- If Arcadia determines that there is a better offer for the customer than their current supply option, Arcadia emails the customer with details on the proposed plan on the customer's behalf. We only switch customers to fixed-rate supply plans below their current supply option.
- Customer can cancel with Arcadia at any time for no fee.
- Arcadia pays any supplier cancellation fee if the customer chooses to leave the plan selected for them.
- Arcadia is paid a fee by the electric supplier for each customer it signs up to a supply contract. The fee amount is determined separately for each deal.
