Tax Cuts and Jobs Act Rider

Applicability:

To all Customers.

Description:

All customers shall be assessed a credit of 0.354% of the customer's applicable base distribution charges (i.e., customer charge plus volumetric charge) to refund the natural gas distribution share of benefits resulting from the Tax Cuts and Jobs Act of 2017. This Rider shall be adjusted annually to refund amounts authorized by the Commission.
