MEMORANDUM IN SUPPORT OF MOTION FOR SUBPOENA OF OHIO POWER SITING BOARD STAFF REPRESENTATIVE(S)

New Market Solar ProjectCo 1, LLC and New Market Solar ProjectCo 2, LLC (collectively, "New Market Solar") seek a subpoena of the Ohio Power Siting Board ("Board") Staff member who was responsible for reviewing the final civil engineering drawings submitted to Staff on or about March 19, 2021. Good cause exists to grant this motion.

Board Staff review of the final engineering drawings was an explicit condition of the certificate issued by the Board. See In re the Application of Hecate Energy Highland 4 LLC for a Certificate of Environmental Compatibility and Public Need, Case No. 20-1288-EL-BGN, Opinion, Order and Certificate (Mar. 18, 2021) at 26 (the "Certificate"). Specifically, Condition 8 of the Certificate required that engineering drawings be provided to Staff for review. Given that this proceeding involves the issue of whether the Project is in compliance, the parameters, substance and results of Staff's review of these final engineering drawings¹ pursuant to Condition 8, are relevant to this matter.

Ohio Adm.Code 4906-2-23 establishes a right for parties to obtain subpoenas for testimony at the adjudicatory hearing. The Supreme Court of Ohio explicitly affirmed this right in *In re the* Application of Black Fork Wind Energy, L.L.C., 138 Ohio St. 3d 43, 48 (2013). Here, issuance of the requested subpoena is necessary for a full factual development of the record before the Board

and is not unreasonable or oppressive. On the contrary, failure to issue the subpoena will deprive New Market Solar of the opportunity to present to the Board all relevant evidence with respect to this matter.

For these reasons, New Market Solar respectfully requests that the Administrative Law Judge grant its motion for the attached subpoena.
