This letter is submitted on behalf of PAETEC iTel, L.L.C. ("PAETEC iTel") to notify the Public Utilities Commission of Ohio ("Commission") of its intent to begin requesting telephone numbers from the Numbering Administrators. Pursuant to the Federal Communications Commission's ("FCC") FCC 15-70 Order, allowing interconnected VoIP providers to obtain resources directly from the North American Numbering Plan Administrator and/or the Pooling Administrator, PAETEC iTel, hereby notifies the Commission of its intent to request the resources identified below. The FCC granted PAETEC iTel Interconnected VoIP Numbering Authorization on November 8, 2023, in DA 20-416.
