MOTION FOR EXTENSION OF CERTIFICATE**

Save On Energy, LLC (“Save On Energy”) is a certified Competitive Retail Electric Service Provider under certification Case No. 13-1989-EL-AGG. The end date for Save On Energy’s most recent Ohio Competitive Retail Electric Service Provider Certificate (the “certificate”) was January 23, 2024. Save On Energy attempted to file its application to renew the certificate on that date, but the application was considered filed as of January 24, 2024. Save On Energy now brings this motion for an extension pursuant to Rules 4901:1-24-04 and 4901:1-24-10, as well as the Commission’s June 3, 2020 Entry in Case No. 20-1077-GE-WVR.

As set forth more fully in the attached memorandum in support, Save On Energy respectfully seeks: (i) an extension of its current certificate during the pendency of the new application review; and (ii) the authority to operate during the pendency of the pending certification application.

**MEMORANDUM IN SUPPORT OF
SAVE ON ENERGY, LLC'S
MOTION FOR EXTENSION OF CERTIFICATE**

Save On Energy, LLC ("Save On Energy") is a Competitive Retail Electric Service Provider. Save On Energy's Ohio Competitive Retail Electric Service ("CRES") provider certificate was issued in Case No. 13-1989-EL-AGG (the "certificate").

Rule 4901:1-24-09 requires CRES renewal applications to be filed no less than thirty and no more than sixty days prior to the certificate expiration date. If an application for renewal is not filed prior to the expiration date on the certificate, the CRES provider may file a new application and also may request to extend its previous certificate during the pendency of the new application review. O.A.C. 4901:1-24-04.¹ The request for an extension will be deemed automatically approved unless ruled otherwise by the Commission or an Attorney Examiner within three business days, and provided that the request is made no later than sixty days after the expiration date on the certificate. *Id.* The Commission has thirty days to act on an application to renew a certification. O.A.C. 4901:1-24-10.

The expiration date for Save On Energy's CRES provider certificate was January 23, 2024. Due to administrative issues associated with filing its renewal papers, Save On Energy's renewal

was not filed until after 5:30 p.m. on January 23, 2024. The filing was considered filed the next business day—*i.e.*, January 24, 2024—because it was made after business hours.

In order to facilitate the proper renewal, and to ensure that Save On Energy will be able to service its customers in Ohio during the pendency of its application, Save On Energy respectfully requests: (i) an extension of its current certificate during the pendency of the new application review; and (ii) the authority to operate during the pendency of the pending certification application.
