Now comes Lakepoint Energy, LLC ("Lakepoint"), by and through undersigned counsel, and hereby requests an extension of the expiration date of Certificate No 18-1293E ("Certificate"), certifying Lakepoint as an electrical aggregator. Lakepoint respectfully requests the Commission extend its Certificate, so it may remain in effect during the pendency of its Competitive Retail Electric Service Provider Application ("Renewal").

For cause, Lakepoint's renewal was executed and sent to the commission on February 29, 2024. Admittedly, the Renewal was sent later than anticipated due to an oversight by the company Lakepoint works with for the submission of this information. Further, Lakepoint's managing member, Steve Egger, was informed it may take roughly thirty (30) days for the Renewal to process.
