**RESOLUTION --- AUTHORIZING THE SENECA COUNTY COMMISSIONERS TO ACT AS THE PURCHASING AGENT AND GOVERNMENTAL AGGREGATOR FOR ELECTRIC POWER FOR ADAMS TOWNSHIP.**

The ADAMS TOWNSHIP TRUSTEES, Seneca County, Ohio, met in regular session on the \_ day of \_ 2024, at the office of the Township Trustees with the following members present:

Trustee Dave Carrothers moved the adoption of the following resolution:

Whereas, on March 19, 2024, the residents of Adams Township voted in favor of electric aggregation to improve purchasing leverage and offer reduced electrical generation rates to residential and small business consumers, and,

Whereas, the Seneca County Commissioners have offered their services to act on behalf of all Townships in Seneca County as the governmental aggregator, and,

Whereas, having one centralized aggregator will provide for the most expeditious manner to handle any issues arising in the process of electrical aggregation,

**THEREFORE, Be It Resolved,**

Section 1. The Township Trustees of Adams Township hereby authorize the Seneca County Commissioners to act as the governmental agent for purchasing and aggregation of electric power for the residents of Adams Township.

Section 2. This resolution shall be copied to the Seneca County Commissioners, 111 Madison St, Tiffin Ohio 44883

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were so adopted in an open meeting of this Township, and that all formal actions, were in meetings open to the public, in compliance with all legal requirements. )
