ENTRY

The attorney examiner, pursuant to the authority granted by Rule 4901-1-14, Ohio Administrative Code, finds:

- (1) By Finding and Order issued June 6, 1996, the Commission issued its requirements for the disclosure or use of 9-1-1 database information. Among the requirements, as set forth in II.A.2. of Appendix A of the Finding and Order, is that telephone companies file a 9-1-1 database disclosure tariff within 60 days of a request by a public utility or municipal utility.
- On September 6, 1996, GTE North Incorporated (GTE) filed a (2) motion to extend the time to file a database disclosure tariff. GTE informs the Commission that it has received requests for the service from Centerior Energy Corporation (Centerior), Columbus Southern Power Company, and Ohio Power Company (Ohio Power). GTE notes that it received the first request on July 10, 1996. According to GTE, its tariff was due September 9, 1996. GTE explains that the requesting companies, until recently, were formulating the format of the database that they desired and determining the frequency of updates that they need. As a result, GTE states that it was unable to finalize its tariff offering within the Commission's 60 day time period. GTE, therefore, requests that it be granted an additional 30 days within which to file a tariff. It is anticipated that the tariff will be filed on or before October 9, 1996.
- (3) On September 13, 1996, ALLTEL Ohio, Inc. (Alltel) and The Western Reserve Telephone Company (Western Reserve) filed a motion to extend the time within which to file a database disclosure tariff. Alltel and Western Reserve state that they received requests for the service from Centerior and Ohio Power. Alltel and Western Reserve state that there are continuing discussions with Centerior and Ohio Power concerning the tariff, and for this reason the tariff remains incomplete. To complete the tariff, Alltel and Western Reserve request an extension of 30 days. The tariff would be due on or before October 7, 1996.

(4) The motions to extend time appear to be reasonable and without undue prejudice to any party. The motions should, therefore, be granted. Accordingly, GTE shall be permitted to file its database disclosure tariff on or before October 9, 1996. Alltel and Western Reserve shall be permitted to filed their database disclosure tariffs on or before October 7, 1996.

It is, therefore,

ORDERED, That the motions to extend time filed by GTE, Alltel, and Western Reserve shall be granted. Accordingly, GTE shall be granted until October 9, 1996 to file its database disclosure tariff. Alltel and Western Reserve shall be granted until October 7, 1996 to file their database disclosure tariff. It is further,

ORDERED, That copies of this entry be served upon GTE, Alltel, Western Reserve, their respective counsel, and all interested persons of record.
