**DESCRIPTION OF SERVICE TERRITORY**

The service area of the Aqua Ohio, Inc., Lake Erie East Division, in Ashtabula County, Ohio, shall include the Village of Jefferson and portions of Lenox, Morgan, and Rome Townships. The boundaries of the Service Area in Ashtabula County are more specifically described as follows;

The Village of Jefferson as described by municipal boundaries;

The portions of Lenox, Morgan, and Rome Townships are described as follows;

Beginning at a point, said point being made by the intersection of the south line of Austinburg Township and a line offset 1,000 feet to the west of the centerline of State Route 45;

Thence generally southerly along said line offset 1,000 feet to the west of the centerline of State Route 45 to a point, said point made by the intersection of said line offset 1,000 feet to the west of the centerline of State Route 45 and the north corporation line of the Village of Rock Creek;

Thence easterly, southerly, and westerly along the corporation line of the Village of Rock Creek to a point, said point made by the intersection of the south corporation line (extended) of the Village of Rock Creek and a line offset 1,000 feet to the west of State Route 45;

Thence generally southerly along said line offset 1,000 feet to the west of the centerline of State Route 45 to a point, said point made by the intersection of said line offset 1,000 feet to the west of the centerline of State Route 45 and a line offset 1,000 feet to the south of the centerline of U.S. Route 6;

Thence easterly along said line offset 1,000 feet to the south of the centerline of U.S. Route 6 to a point, said point made by the intersection of said line offset 1,000 feet to the south of the centerline of U.S. Route 6 and the east line of Rome Township;

Thence northerly along the east line of Rome and Morgan Townships to a point, said point made by the intersection of said east Morgan Township Line and the south right-of-way line of the Footville-Richmond Road;

Thence generally easterly along said south right-of-way line of the Footville-Richmond Road to a point, said point being made by the intersection of said south right-of-way line and the east line of Lenox Township;
