Dear Ms. Crockron:

On December 22, 2000 Cincinnati Bell Telephone Company (CBT) proposed to revise its Out of Territory Services Tariff, PUCO No. 1, to provide a special promotion of its Complete Connections Service. All residential customers who subscribed to Complete Connections during the promotion period January 1, 2001 through February 28, 2001 received a credit amount of \$18.00 toward the first month's recurring charge for Complete Connections Service.

On February 28, 2001, CBT amended the filing to extend the promotion through May 31, 2001. CBT would like to now **discontinue** the above promotion that would have expired on the extended date of May 31, 2001. CBT will honor the terms of the discontinued promotion with all eligible **residential** customers who enrolled in the promotion prior to or on the discontinuation date of this promotion, March 1, 2001.

CBT proposes to file a new promotion similar to the discontinued promotion with the following exceptions: 1) the residential customers eligible for the promotion would only be those customers who establish new local exchange service or who move from one location in CBT's serving area to another within CBT's serving area and 2) the promotion period would begin March 2, 2001 and end on April 1, 2001. These residential customers would receive the same **credit amount of** \$18.00 toward the first month's recurring charge for Complete Connections Service.

In accordance with the Commission's guidelines for promotional offerings established in Case No. 90-2021-TP-ATA, Case No. 90-5013-TP-TRF, Case No. 93-1020-TP-ATA and the Finding and Order in Case No. 99-1496-TP-UNC, to apply CBT's *Commitment 2000 Plan* to CBT's operations outside of its existing territory, we are forwarding for filling three copies of the tariff pages describing the promotional offerings. CBT Out of Territory Services Tariff PUCO No. 1, Section 5, Original Page 174 specifies the rate and terms that will be in effect for the service included in this promotion. We are also forwarding for filling three copies of the tariff pages associated with the discontinuation of the extended promotion.
