For its Complaint against SBC Communications, Inc. and SBC Ohio (hereinafter collectively, "SBC"), Plaintiff, Rick Angheld Real Estate Group, Inc. (hereinafter "Angheld") states as follows:

PRELIMINARY ALLEGATIONS

- Angheld is a Corporation duly licensed to do business in the State of Ohio,
 with its principal place of business located in Cuyahoga Falls, Ohio.
- On information and belief, SBC, is a Corporation duly licensed to do business in the State of Ohio, with its principal place of business located in San Antonio, Texas and additional office in Cleveland, Ohio.

- 3. On or about May, 2004, Angheld and SBC entered into a Telecommunication Service Provider Relationship ("Relationship") which called for SBC to sell to and provide Angheld various Telecommunication services such as business phone service, lines, and related services such as call waiting, call forwarding, call transferring and advertising in the SBC Yellow Pages.
- 4. Angheld's account number with SBC was 330 836-8361 7611 and Customer Id was 4005596648 for the service address of 2800 State Road Cuyahoga Falls, Ohio 44223 and later 2998 West Market Street, Fairlawn, Ohio 44333 with the telephone number (330) 929-5626.
- 5. Pursuant to said Relationship, Angheld requested and was sold a business telephone system that was advertised to be able to handle a high volume real estate business' incoming and outgoing phone calls as well as handle all the other related service functions Angheld required to operate its business (collectively "System").
- 6. From the beginning of the Relationship Angheld had problems with the System as sold to it by SBC including dead phones, lost calls, inability to provide services as sold and contracted for, poor customer service, phone number problems, unauthorized account maintenance and setup, overcharges, and yellow page misprints and listing errors.
- 7. To date, the System problems and SBC's failure to address the same have caused Angheld to be damaged in an amount in excess of Twenty-Five Thousand Dollars (\$25,000.00).

COUNT ONE (BREACH OF CONTRACT)

- Angheld incorporates the allegations contained in the above paragraphs as
 if fully rewritten herein.
- 9. Angheld and SBC entered into a Telecommunication Service Provider Relationship and contract ("Relationship") which called for SBC to sell to and provide Angheld various Telecommunication services such as business phone service, lines, and related services such as call waiting, call forwarding, call transfers and advertising in the SBC Yellow Pages.
- 10. Pursuant to said Relationship, Angheld entered into a Contract with SBC for the sale of a business telephone system that was advertised to be able to handle a high volume real estate businesses incoming and outgoing phone calls as well as handle all the other voice and data related service functions Angheld required to operate its business (collectively "System"). A copy of various contractual documents related to the Relationship and System are attached hereto as Exhibit A and incorporated by this reference.
- 11. SBC breached the terms of the Contract by switching service without notification that caused days of lost calls, failing to provide the services as requested and agreed upon by Angheld, setting up additional phone lines not authorized by Angheld and billing for them, running misprinted yellow page ads that caused customers who called to receive a "this number has been disconnected" message. And listing wrong phone numbers and disconnected phone lines which caused substantial customer loss and

caused the impression that Angheld is out of business. Copies of the yellow page ad proofs and the corrections Angheld kept making are attached hereto as Exhibit B.

- 12. SBC's actions have caused Angheld to incur substantial damages of loss of customers and potential customer business due to lost calls from switching services, loss of customers and potential customer business due to lost calls from incorrect yellow page ads between January 1, 2005 and April 1, 2005, charges from unauthorized accounts and lines setup by SBC, and loss of employee time to address the numerous problems caused by SBC's breach.
- 13. As a direct and proximate result of SBC's breach, Angheld has suffered damages in an amount in excess of Twenty Five Thousand Dollars (\$25,000.00), prejudgment interest, and reasonable attorney fees.

COUNT TWO (PROMISSORY ESTOPPEL DETRIMENTAL RELIANCE)

- 14. Angheld incorporates the allegations contained in the above paragraphs as if fully rewritten herein.
- 15. Angheld and SBC entered into the Relationship which called for SBC to sell to and provide Angheld various Telecommunication services such as business phone service, lines, and related services such as call waiting, call forwarding, call transfers and advertising in the SBC Yellow Pages.
- 16. Pursuant to said Relationship, Angheld entered into a Contract with SBC for the sale of the business telecommunications System.

- 17. Angheld relied to its detriment on the contractual Relationship entered into with SBC.
- 18. SBC breached the terms of the Contract by switching service without notification that caused days of lost calls, failing to provide the services as requested and agreed upon by Angheld, setting up additional phone lines not authorized by Angheld and billing for them, running misprinted yellow page ads that caused customers who called to receive a "this number has been disconnected" message. And listing wrong phone numbers and disconnected phone lines which caused substantial customer loss and caused the impression that Angheld was out of business.
- 19. SBC's actions have caused Angheld to incur substantial damages of loss of customers and potential customer business due to lost calls from switching services, loss of customers and potential customer business due to lost calls from incorrect yellow page ads between January 1, 2005 and April 1, 2005, charges from unauthorized accounts and lines setup by SBC and loss of employee time to address the numerous problems caused by SBC's breach.
- 20. As a direct and proximate result of SBC's breach, Angheld has suffered damages in an amount in excess of Twenty Five Thousand Dollars (\$25,000.00), prejudgment interest, and reasonable attorney fees.

COUNT THREE (DECEPTIVE TRADE PRACTICES ACT)

21. Angheld incorporates the allegations contained in the above paragraphs as if fully rewritten herein.

- 22. SBC knowingly and intentionally committed unfair, deceptive and unconscionable acts and practices, as defined in R.C. §4165.02 and 4165.03 with regard to representations as to the cost of services and quality of services as provided and by disparaging the business of Angheld by falsely representing to others through SBC's yellow page listings that Angheld had disconnected phone lines and otherwise appeared to be out of business.
- 23. SBC, intentionally and with malice, induced Angheld to enter into a contractual relationship which represented services that SBC was to provide to Angheld to be of a particular grade or quality and have particular uses or benefits to Angheld when such services were not of the grade and/or quality as represented nor did such services have the particular uses and/or benefits to Angheld which SBC represented.
- 24. Furthermore, SBC, intentionally and with malice, disparaged the business of Angheld by falsely representing to others, by and through SBC's yellow page listings that Angheld had disconnected phone lines and otherwise appeared to be out of business.
- 25. Angheld relied upon the representations of SBC when it entered into a contractual relationship with SBC and which has caused Angheld to lose customers, potential customers, lost calls from incorrect yellow page ads between January 1, 2005 and April 1, 2005, and loss of employee time to address the numerous problems SBC caused.
- 26. Angheld is entitled to remedies as set forth in R.C. § 4165.03 including actual damages and reasonable attorneys fees.

COUNT FOUR (TORTIOUS INTERFERENCE WITH BUSINESS RELATIONSHIPS)

- 27. Angheld incorporates the allegations contained in the above paragraphs as if fully rewritten herein.
- 28. Angheld and SBC entered into the Relationship which called for SBC to sell to and provide Angheld various Telecommunication services such as business phone service, lines, and related services such as call waiting, call forwarding, call transfers and advertising in the SBC Yellow Pages.
- 29. Pursuant to said Relationship, Angheld entered into a Contract with SBC for the sale of the business telecommunications System.
- 30. SBC breached the terms of the contract Relationship by switching service without notification that caused days of lost calls, failing to provide the services as requested and agreed upon by Angheld, setting up additional phone lines not authorized by Angheld and billing for them, running misprinted yellow page ads that caused customers who called to receive a "this number has been disconnected" message. And listing wrong phone numbers and disconnected phone lines which caused substantial customer loss and gave the impression that Angheld was out of business.
- 31. Furthermore, SBC, intentionally and with malice, interfered with the business of Angheld by falsely representing to others, by and through SBC's yellow page listings that Angheld had disconnected phone lines and otherwise appeared to be out of business.

- 32. SBC's intentional and improper actions interfered with Angheld's prospective contractual relationships with numerous customers which has caused Angheld the loss of benefits to those contractual relationships.
- 33. SBC's actions have, among other things, caused Angheld to incur substantial damages and harm due to the loss of business and incurred substantial attorney's fees.
- 34. As a direct and proximate result of SBC's tortious interference with business relations, Angheld has suffered damages in an amount in excess of Twenty Five Thousand Dollars (\$25,000.00), prejudgment interest, and reasonable attorney fees.

WHEREFORE, Angheld prays that this Court award it the following relief against SBC as follows:

On Count One, Count Two, Count Three, and Count Four Rick Angheld Real Estate Group, Inc. prays for judgment against SBC Communications, Inc. and SBC Ohio, jointly and severally, for compensatory damages in an amount in excess of \$25,000.00, attorney fees and such other relief as this Court deems fair and equitable,

including, but not limited to prejudgment and post judgment interest.




