1. Terms and Conditions

a. This promotion is for business customers who subscribe to anywhere from 3 to 24 business complete connection services or 4 to 24 Centrex 2000 deluxe service lines and who are willing to sign a 36-month contract.

b. Promotional Offering

1. Eligible customers, as described above, will receive a discounted monthly rate for the bundle of Centrex services or complete connection services and a waiver of all nonrecurring charges associated with the services. For a customer purchasing 3 – 12 lines the monthly bundle rate will equate to \$50 multiplied by the number of Centrex Lines or complete connections that the customer subscribes to. For a customer purchasing 13 – 24 lines the monthly bundle rate will equate to \$40 multiplied by the number of Centrex Lines or complete connections that the customer subscribes to. Each line will include hunting and calling name and number services.
2. If the customer chooses to subscribe to the direct asymmetrical digital subscriber line service, 3.0 Mbps, the customer will receive a discounted monthly rate on the DSL service, of \$100. This charge is in addition to the monthly rate for the business complete connections/Centrex services.
3. Customer is required to sign a 36-month contract
4. Early contract termination charge language will be included in the contract.
