RESOLUTION NO. 204-97

A RESOLUTION FOR THE COLLECTIVE AGGREGATE BIDDING OF NATURAL GAS CONSUMPTION AND PETITIONING THE PUBLIC UTILITIES COMMISSION OF OHIO AND COLUMBIA GAS COMPANY FOR A PROGRAM WITHIN THE CITY AND DECLARING AN EMERGENCY

WHEREAS, the City of Parma desires to offer the Columbia Gas Customer Service Choice Program to the Citizens of the City; and,

WHEREAS, the City of Parma would like to be the first city chosen by Columbia Gas of Ohio to be the beta site for the Northeast Ohio market; and,

WHEREAS, the City of Parma will offer Natural Gas Utility Aggregation Service to its residents; and,

WHEREAS, through natural gas and electric power aggregation, the City of Parma could significantly reduce the cost of energy to its residents; and,

WHEREAS, the City of Parma would like to offer its residents natural gas cost reductions through participation in the Columbia Gas Customer Choice Program; and,

WHEREAS, the City of Parma will qualify and approve all natural gas marketers who will sell products and service to the residents; and,

WHEREAS, the City of Parma will engage the professional services of an independent third party who will not profit from the sale of any natural gas to qualify and present to Council for approval any third party marketer who will sell products and services within the City; and,

WHEREAS, the City of Parma will not put any residents, businesses, or tax dollars at risk for the program; and,

WHEREAS, the City of Parma will require that a qualified marketer approved to offer products and services to any of the residents or businesses of the City offer both natural gas and electric power service;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PARMA, STATE OF OHIO:

Section 1. That this Council of the City of Parma hereby supports the Collective Aggregate Bidding of Natural Gas Consumption and petitioning the Public Utilities Commission of Ohio (PUCO) and Columbia Gas Company for a program within the City.

Section 2. That the Clerk of Council be, and he hereby is, directed to forward a certified copy of this Resolution to: Greg Scheck, Utilities Supervisor, PUCO; Deborah Gnann, Director of Consumer Services, PUCO; PUCO, Docketing Division; and Columbia Gas of Ohio.

Section 3. That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of the Council and any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 4. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety, and welfare of the City of Parma, and for the further reason that this measure is necessary in order for residents to realize lower monthly utility bills, and this Resolution shall become immediately effective upon receiving the affirmative vote of two-thirds of all members elected to Council and approval of the Mayor, otherwise from and after the earliest period allowed by law.
