Dear Forrest:

As you know, there are currently several agency program applications pending with the Commission which were filed by the former West Ohio Gas Company prior to its merger with East Ohio Gas on January 1, 1997. Enclosed with this letter is a separate status listing of those pending applications. As you can see, in the majority of these cases, the original contract term has already expired. For those which have not expired, East Ohio will not be seeking renewal after expiration.

Currently, East Ohio is not serving any customers under the former Agency Program, including any customers within the West Ohio Division. These former West Ohio agency customers are all being served by another supplier effective November 1, 1996, and East Ohio continues to provide transportation service to them.

With regard to Case No. 95-923-GA-AEC, Swan Coin Laundries, it appears this case filed by Ohio Gas Company on October 10, 1995, and it was inadvertently included with your listings for West Ohio Gas.
