Dear Ms. Crockron:

Cincinnati Bell Telephone Company (CBT) proposes to revise its Out of Territory Services Tariff PUCO No. 1 to provide a special promotion of its **pay-per-use** services to **residential** customers. The **pay-per-use** services include **Three-Way Calling, Call Return, and Repeat Dialing Services**. CBT will waive the \$.95 per usage charge normally associated with the **pay-per-use** services during the promotion period which will be Christmas Day, December 25, 2000.

In accordance with the Commission's guidelines for promotional offerings established in Case No. 90-2021-TP-ATA, Case No. 90-5013-TP-TRF, Case No. 93-1020-TP-ATA and the Finding and Order in Case No. 99-1496-TP-UNC, to apply CBT's *Commitment 2000 Plan* to CBT's operations outside of its existing territory, we are forwarding for filing three copies of the tariff pages describing the promotional offerings. The new tariff pages specify the rates and terms that will be in effect for the service included in this promotion.
