Between Two Exchanges of SBC Ohio.) Case No. 02-3055-TP-ACB

ENTRY

The Commission finds:

- (1) On November 22, 2002, SBC Ohio, formerly Ameritech Ohio, filed revised maps and tariff sheets on behalf of The Ohio Bell Telephone Company to reflect a change in the company's telephone boundaries, pursuant to Rules 4901:1-3-03(F), (G), and (L), Ohio Administrative Code (O.A.C.). On January 10, 2003, SBC Ohio filed a letter, as requested by Commission Staff, to provide additional details regarding the proposed boundary change.
- (2) The revised maps reflect a boundary change that incorporates a small portion of SBC Ohio's Reynoldsburg Exchange into SBC Ohio's Canal Winchester Exchange.
- (3) SBC Ohio states this change is necessary because of an Ohio Department of Transportation initiated movement of a road in the Canal Winchester Exchange. The movement of the road caused a forced relocation of a single SBC Ohio business customer to a nearby new location in the Reynoldsburg Exchange. This boundary change will accommodate the customer's request to allow it to retain its Canal Winchester Exchange number and local calling area.
- (4) Pursuant to Rule 4901:1-3-03(F)(1), O.A.C., SBC Ohio confirms that it has the facilities necessary to serve the incorporated service area, without adversely affecting the service furnished to any existing subscriber.
- (5) The Commission finds that the proposed boundary change request and the corresponding revised tariff sheets should be approved and this matter closed of record.


ORDERED, That the proposed boundary change and revised tariff sheets filed on November 22, 2002, are approved. It is, further,




