Dear Ms. Crockron:

Cincinnati Bell Telephone (CBT) proposes to revise its **General Exchange Tariff PUCO No. 8** in order to conduct a promotion on its **Asymmetrical Digital Subscriber Line Service**. This promotion offers **residential** customers who subscribe to the ADSL 768 KBPS/384 KBPS Service during the promotional period, a **\$20.00 discount** off of the monthly charges associated with the service for the first 3 months of service. After the 3 months are over the monthly charge will revert to the tariffed rate. This promotion will be in effect from January 15, 2001 through February 28, 2001.

C. RATES

1. RECURRING CHARGES
