The attorney examiner finds:

- 1) Each of these cases involves an application for a new certificate seeking operating authority to transport household goods within Ohio.
- 2) At the request of the parties in many of these cases, the application was held in abeyance pending a decision by the Supreme Court of Ohio for an appeal of the Commission's Order in the Andrews case (Canton Storage & Transfer Co. v. Pub. Util. Comm., 99 Ohio St. 3d.1). The court's decision was issued several months ago and not one of these applicants has moved forward with its application.

- 3) In light of the extraordinary length of time most of these cases have been pending before the Commission, the examiner will move these applications forward.

Any applicant failing to so file will face dismissal of its application.
- 5) All remaining applicants and protestants are directed to appear for a prehearing conference on these cases at 9:00 a.m. on January 18, 1996 at the offices of the Commission. Any applicant failing to so appear at the prehearing conference will face dismissal of its application. Any protestant failing to so appear will have its protest(s) dismissed in these cases.


It is, therefore,

ORDERED, That each applicant wanting to proceed with its application file a statement to that effect with the Commission no later than January 10, 1996. It is, further,

ORDERED, That these cases be scheduled for Prehearing Conference as set forth in Finding 5. It is, further,

ORDERED, That a copy of this entry be served upon all parties of record.


