The Attorney Examiner finds:


- (1) On August 26, 2002, First Choice Transportation Service (Complainant), filed a complaint against SBC/Ameritech (Respondent) alleging that Respondent failed to notify this transporter of school children and dialysis clients that it would be without telephone service for two days due to telephone company construction causing Complainant to suffer damages.
- (2) Pursuant to Rule 4901-9-01, O.A.C., the Secretary of the Commission served a copy of the complaint on Respondent and directed Respondent to file an answer to the complaint, along with any responsive motion, with the Commission and serve a copy of the answer and any motion upon the Complainant.
- (3) This matter should be set for a settlement conference to be held on September 24, 2002, at 10:00 a.m., in Hearing Room 11-F at the offices of the Commission, on the 11<sup>th</sup> Floor of 180 East Broad Street, Columbus, Ohio. The purpose of the settlement conference is to determine whether this matter can be resolved without a formal hearing. Any person representing a party at the settlement conference shall have authority to settle the case. If the parties are unable to resolve the complaint at the settlement conference then the parties and the mediator should narrow the issues raised by the complaint for hearing and establish a preferred hearing date. The parties should bring with them all documents relevant to this matter.

It is, therefore,

ORDERED, That a settlement conference be held in this matter on September 24, 2002, at 10:00 a.m., in Hearing Room 11-F at the offices of the Commission. It is, further,

ORDERED, That a copy of this Entry be served upon each party of record.


