Richard Welling, Affiant, being duly sworn and affirmed according to law, deposes and says that he is a Lake Township Trustee, Lake Township, Ohio, and that he is authorized to and does make this affidavit for said Applicant:

1. The Applicant herein, attests under penalty of false statement that all statements made in regards to the Opt Out forms are true and complete and further, Applicant will amend its certificate in case 04-38-EL-GAG as deemed necessary if any substantial changes occur regarding the information provided in the Aggregation Disclosure Statement and Opt Out Notice attached.
2. Substantial changes may include but be not limited to the following information:
  - (a) Statement in the Opt-Out Notice informing customers that if they switch back to the electric distribution utility (EDU) in the area, Toledo Edison, that they may not be served under the same rates and conditions that apply to other customers served by Toledo Edison;
  - (b) Statement in the Opt-Out Notice discussing budget billing indicating that customers having current budget billing arrangements with Toledo Edison may remain under budget billing for the portions of their bill pertaining to services with Toledo Edison, however the portion of the bill pertaining to ***Retain Electric Generation Provider (to be determined)*** will not be budget billed.




