Cincinnati Bell Telephone Company (CBT) proposes to revise its **Out of Territory Services Tariff PUCO No. 1** to include a promotion on the Integrated Advantage Lite Service. This promotion offers **business customers who subscribe to a 36 month Integrated Advantage Lite** contract, a waiver of the nonrecurring charges associated with this service. This promotion will be in effect from April 1, 2001 through April 30, 2001.

In accordance with the Commission's guidelines for promotional offerings established in Case No. 90-2021-TP-ATA, Case No. 90-5013-TP-TRF, Case No 93-1020-TP-ATA and the Finding and Order in Case no. 99-1596-TP-UNC, which requires CBT to apply the Commitment 2000 Plan to operations outside of its existing territory, we are forwarding for filing three copies of the tariff pages describing the promotional offerings. The new tariff pages specify the rate and terms that will be in effect for the services included in these promotions.
