

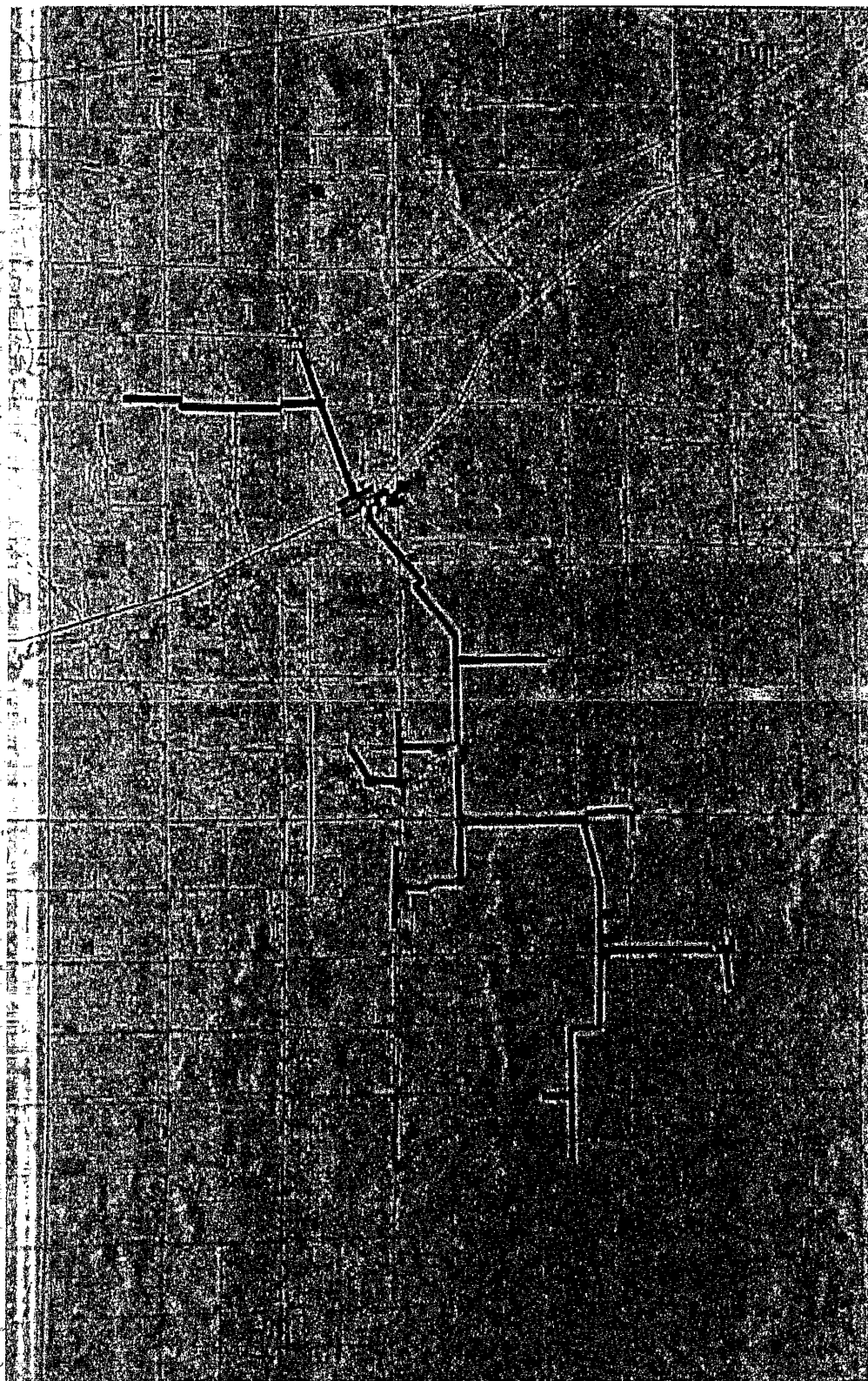

The Public Utilities Commission of Ohio (PUCO) is currently investigating the ability of the West Millgrove Gas Company to provide gas service to our customers this winter. As part of the investigation, the Commission will determine if West Millgrove has an adequate supply of gas to serve our customers, and if not, will decide if the attorney general should be asked to appoint a receiver to assure that our customers will continue to receive gas service.

The PUCO will hold a public hearing on Tuesday, November 21, 2000, beginning at 10:00 a.m., at the offices of the Commission, 11th Floor, 180 East Broad Street, Columbus, Ohio 43215. The purpose of the hearing is to determine if West Millgrove does have an adequate supply of gas for our customers.
