Privacy Manager Retention Offer

A retail promotional period shall be established from October 28, 2002 through January 24, 2003.

During this promotional period, existing residential customers who currently subscribe to Privacy Manager, and who call to disconnect the service, have the ability to receive \$3 off the service each month for two consecutive months if they agree to retain the service.

Privacy Manager and Caller ID Discount

A retail promotion period shall begin on October 28, 2002 through December 31, 2002 for eligible residence customers who subscribe to both Privacy Manager and Caller ID. This promotion offers new and existing residential customers who subscribe to Privacy Manager and Caller ID outside of a package an offering for \$10.95 per month for six months.

Eligible customers are those that subscribe to both services at the same time or can be subscribers to Caller ID and add Privacy Manager to become eligible for this offer. Customers will receive a credit on their bill that will bring the price of the two services to \$10.95.
