As counsel to CME Energy, Inc. ("CME") and its affiliates Hanging Rock Energy Project, LLC ("Hanging Rock") and Ironton Energy Center, LLC ("Ironton"), it has come to our attention that no request was made to the Ohio Power Siting board ("OPSB") to approve the transfer of the Certificate herein from Lawrence Energy Center, LLC ("Lawrence"), to Hanging Rock and then to Ironton at the time of the transfers. The purpose of this correspondence is to:

(1) respectfully request the approval by the OPSB of said transfers.

Our letter of October 31, 2006, summarizes the history of this project, and the OPSB is respectfully directed to that letter.

As noted, the Lawrence Energy Center Project is now legally owned by Ironton, and Ironton has assumed all development activities associated with the project. Accordingly, Ironton hereby respectfully requests the approval of the OPSB of the transfers of the Certificate from Lawrence to Hanging Rock to Ironton.
