On April 17, 2001, Cincinnati Bell Telephone Company (CBT) proposed to revise its General Exchange Tariff, PUCO No. 8, to provide a special promotion of its Complete Connections Service. **Business** customers who subscribed to Complete Connections receive a **waiver of the first month's recurring charge and the nonrecurring charge** associated with Complete Connections Service.
