In accordance with O.A.C. 4906-3-07, and the Administrative Law Judges' Entry (Entry) issued on December 18, 2018, Duke Energy Ohio, Inc., (Duke Energy Ohio or the Company) is hereby filing its notice of compliance with requirements concerning service and public distribution of the application filed in the above-referenced proceeding.

A copy of the application is available for public inspection at the main office of Duke Energy Ohio at 139 E. Fourth Street, Cincinnati, Ohio 45202, and at the offices of the Ohio Power Siting Board, 180 East Broad Street, Columbus, Ohio 43215.

It is also available on the Duke Energy Ohio website, at: <https://www.duke-energy.com/home/natural-gas/central-corridor-pipeline-ext>, together with instructions on how to obtain a paper copy. Additionally, the application is on the Ohio Power Siting Board's website, at: www.opsb.ohio.gov. Lastly, a notice of availability of the application has been sent to the Public Library of Cincinnati and Hamilton County.

The Entry required the Company to serve a copy of the application on the owners of any newly affected properties. There are two properties affected as a result of the amendment to the application, filed April 13, 2018. However, as the owners of those properties have already been included in property owner notifications in this proceeding, additional service on those owners is not called for by the Entry:

- The owner of the first property acquired it in February 2016 and was therefore included in the Company's previous mailings to owners and tenants. The local municipality has also owned the property in question at certain times during the last three years. However, that municipality has also been included in the previous notifications.

- The second property in question was impacted by the original application filed in September 2016 and was therefore included in the Company's mailings. Although the May 2017 adjustments resulted in the proposed centerline being off the property, the owner was retained in the notification list.

On Friday, January 11, 2019, the Company mailed copies of the amendment to the application on electronic media to the required public officials as listed below. Then, as demonstrated by the attached correspondence, on January 11, 2019, January 14, 2019, and January 16, 2019, the Company also electronically notified those officials that they would be receiving the electronic copies.
