On April 15, 2013, Duke Energy Ohio submitted its portfolio of energy efficiency and peak demand reduction programs for approval by the Public Utilities Commission of Ohio. Included in this filing on pages 24 and 25 of the application were two tables illustrating the impacts and participation and costs for the Home Energy Solutions program. The first table contained kW, kWh impacts and participation and the second table contained annual total utility costs. These tables only included the Energy Efficiency portion of the program, and the kW impacts and costs for the Demand Response component of the program were unintentionally omitted. 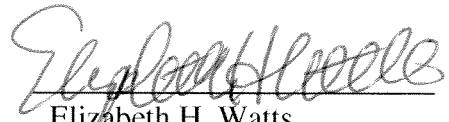
