Dear Ms. McNeal:

Pursuant to a request from the Attorney Examiner in the above-captioned proceeding, Duke Energy Ohio, Inc., (Duke Energy Ohio) is providing copies of Staff's data request and the Company's responses to date.

Provided attached is Staff's Data Request No.1, and the Company's three responses to that request. Please note that the second and third response were provided in response to informal requests. In the follow up to initial production, Staff requested that the Company provide the actual documents referenced in the initial response. Thereafter, in a second follow up, Staff requested that the Company circle the relevant number on the spreadsheets provided. In that case, instead of circling numbers, the Company extracted the numbers from the documents and provided a chart.

In a conversation with Staff subsequent to this morning's teleconference with all parties, Staff clarified its current request. The Company understood that the Staff is requesting projections for years 2009 through 2012, during which the Company's energy efficiency cost recovery mechanism was called save-a-watt. Pursuant to this cost recovery mechanism, the Company did not provide projections, so there are no projections to provide.

Additionally, Staff requested more legible spreadsheets for review, however, on January 11, 2017, live Excel spreadsheets for each of the attachments created by Mr. Ziolkowski in each of the Company's relevant cases were provided to Staff. Please see email attached.

Accordingly, at this time the Company does not believe there is anything further to provide. Please let me know if there are any questions.

Attached are the specific documents you requested in Staff's DR. 1. We are not including information for 2009 to 2011 because the Company had an entirely different portfolio recovery mechanism during those years. The mechanism was known as Rider save-a-watt (Rider DR-SAW). SAW had a much different cost recovery mechanism and functioned in a way completely different from the next portfolio that began in 2012.

Rider EE-PDR began in 2012. It was approved in Case No. 11-4393. Hopefully the attached information will provide you with what you need.
