This tariff contains the regulations and rates applicable to the provision of telecommunications services offered to commercial Customers by Comtel Telcom Assets LP d/b/a VarTec Telecom, and Clear Choice Communications (hereinafter referred to as the "Company") between and among points within the State of Ohio. Some portions of the services offered by the Company are subject to the jurisdiction of the Federal Communications Commission. This schedule only covers the portion of long distance service that is subject to the Public Utilities Commission of Ohio. The Company does not actively offer in-state intraLATA local toll long distance as a stand-alone service. In-state long distance and intraLATA toll are offered as components of an interstate rate plan. 


