Dear Sir or Madam:

Duke Energy Ohio is proposing to replace a section of an existing natural gas pipeline. Duke Energy Ohio system modeling has identified two (2) segments of the 24" AA00 pipeline that need to be replaced to reduce hoop stress below 20% of the specified minimum yield strength (SMYS). By replacing these segments, the entire AA00 pipeline designation can be changed from transmission to distribution under Pipeline and Hazardous Materials Safety Administration (PHMSA). The Palisades Drive Project addresses one of these segments.

The proposed Palisades Drive Project comprises the replacement of approximately 811 feet of existing pipeline. The proposed pipe will be sized such that calculated hoop stress is below 20% SMYS with a pressure of 170 psi (pounds per square inch (psi)) operating pressure. The pipe will be 24" outside diameter x 0.375" wall thickness, American Petroleum Institute (API) 5L Grade X65 pipe material, and ANSI (American National Standards Institute (ANSI)) ANSI Class 300 fittings will be used. Design requirements of the new 24" pipeline replacement sections include a maximum allowable operating pressure (MAOP) of 500 pounds per square inch gauge (psig) and operating pressure of 170 psig.

In accordance with O.A.C. 4906-1-01 Appendix A, we are required to prepare this Construction Notice for the Ohio Power Siting Board and, in compliance with O.A.C. 4906-6-07, we are hereby providing you with a link to an electronic copy.
