Dear Ms. McNeal:

On April 2, 2013, Duke Energy Ohio, Inc. filed a Stipulation and Recommendation in these proceedings. Subsequent to the filing, the Parties have discovered that there are two minor errors in the document. As a result, the Parties are submitting a corrected version of the Stipulation that was originally submitted. The Stipulation has been corrected as follows:

**On page 7**, last paragraph, the word “calculation” has been inserted, such that the first sentence of that paragraph now reads:

Except as modified herein, the revenue requirement calculation and procedural timelines for Rider AMRP will be the same as was approved in prior proceedings; however, the cost of capital shall be calculated using the debt and equity established in paragraph 2 of this stipulation.

**On Page 13**, upon review it was determined that a footnote regarding additional rate codes was accidentally omitted from the filed document. The verbiage of the new footnote is the same as the first footnote of this nature, but applies to a latter portion of the rate codes section of the settlement.

All of the Parties to these proceedings were advised of the need to make these corrections and no Party expressed any opposition to doing so.
