ADMINISTRATIVE LAW JUDGE CATHCART:

We're going to go ahead and get started here tonight. The Ohio Power Siting Board has assigned for public hearing at this time and place Case No. 17-638-EL-BTX, which is captioned In the Matter of the Application of AEP Ohio Transmission Company for a Certificate of Environmental Compatibility and Public Need for the Ginger Switch-Vigo 138kV Transmission Line Project.

My name is Stacie Cathcart, and with me is Lauren Augostini, and I'm the Administrative Law Judge assigned by the Ohio Power Siting Board to preside over this local hearing.

Also with me is Jon Pawley from the Ohio Power Siting Board staff. We will be available if you have any questions concerning the application or any other general questions you may have. Please feel free to approach us at the completion of this evening's hearing.

At this time I would like to take formal appearances on behalf of the parties in this particular case. On behalf of the Applicant?

MS. BLEND: Thank you, your Honor. On behalf of American Electric Power Trans- -- I'm sorry, AEP Transmission Company, Inc., Christen M. Blend, American Electric Power Service Corporation, 1 Riverside Plaza, 29th floor, Columbus, Ohio 43215.

ADMINISTRATIVE LAW JUDGE CATHCART:

Thank you. The subject matter of this evening's public hearing is the application filed on March 15th, 2018 to construct a new 138 kilovolt transmission line in Ross County, Ohio.

This public hearing is only one aspect of the process for this case. I would note that the adjudicatory hearing for this proceeding is scheduled to take place later in September at the offices of the Ohio Power Siting Board, which is in Columbus, Ohio.

In this case, the Applicant submits that the Ginger Switch-Vigo 138kV Transmission Line project is one component of the overall Ross-Jackson Area Improvement Program, which will improve local service for customers, support economic development, and speed recovery of local service when outages

occur.

AEP states that the purpose of the proposed project is to provide additional transmission service to Ross and Jackson County and to improve electric reliability in the area.

AEP adds that the infrastructure in this area has reached an age that demands rebuilding and redesign in order to meet the needs of customers in the region.

The Applicant notes that much of the load in this area is currently served by an extensive 69 kilovolt distribution system, which will be retired and replaced with a new 138 kilovolt transmission system.

The Applicant states that by establishing a new, higher voltage source, the Company will be able to provide more reliability to the region.

The Applicant states the transition line will be initially energized at 69 kilovolts and energized at 138 kilovolts in an expedited fashion when necessary and once the proper funding has been secured from the distribution customers.

According to the application, the project is located in a rural setting consisting of

primarily wood lots, utility rights-of-way, residential areas, and agricultural properties.

116 residences have been identified as being within a thousand feet of the preferred route, and 132 residences have been identified as being within a thousand feet of the alternate route.

The Applicant plans to begin construction in January 2019 and place the transmission line in service in the summer of 2021.

The purpose of this evening's public hearing is to receive comments from the public regarding AEP Ohio Transition Company's application in this case. It is not intended to be a question and answer session, but instead it's your opportunity to let the Ohio Power Siting Board know what you think about the proposals set forth in the application.

I would also note that the Board's staff filed its Report of Investigation on August 15th, 2018. This is simply a recommendation of the Board's staff and does not necessarily reflect what the Board's final determination will be in this case.

Tonight's hearing is being transcribed by a Court Reporter. If you plan to testify, please speak clearly so that the Court Reporter can

accurately reflect your comments on the record.

Also, if you have prepared a written statement, it would be helpful to provide a copy of that to the Court Reporter as well.

When you arrived, you were offered the opportunity to sign up to testify. After I finish with my introduction I will begin calling witnesses forward that have signed the sign-up sheet and ask you to come up to the table and face the Court Reporter.

Before you present your testimony I will also ask you to make an oath or affirmation that what you're about to say is the truth. I will also ask you to state your name and address for the Court Reporter.

Your testimony will be considered part of the official record in this case, and it will be reviewed by the Board before they make their final decision on the application.

Should you decide that you do not wish to testify when we call your name, you can merely pass to the next witness.

Also, once you finish testifying, or you're just here to observe, you may leave at any time you wish, or stay until the conclusion of the

hearing.

The Board appreciates your participation in tonight's hearing, and we want everyone who wishes to make a public statement to have the opportunity to do so, so please be considerate of others waiting to give their testimony and keep your statements to a reasonable period of time.

At this time I will begin calling witnesses forward, and the first witness I have on the list Juanita Meeker.

Taking farm ground for utilities has been an issue with all farms, and we are no different. We can see other ways to construct the lines.

We question some issues that would impact our farm, mainly a 30-foot sod waterway in the area of the line, with tile buried in the middle of it that's five foot deep.

Our sprayers go around the poles in the farm. The drop between the poles with summer heat is of concern. Losing valuable road frontage and farmland is of a concern.

We have been told there are some ways of getting over that, possibly bridging the waterways. We'd like to make sure that if this is an approved route, that some of those things will be taken into consideration. Thank you.
