To Whom It May Concern:

My name is Doug Herling writing you regarding the proposed solar project in your area. Over the last two years, Angelina Solar has been mapping topography, surface drainage, and tile networks within and in the vicinity of the project. At this stage, we're working to identify points of connectivity between areas that could be occupied by Project infrastructure and areas outside the Project. We are undertaking this effort to ensure that our activities during the construction, operation, and eventual decommissioning of the Project have no adverse effect on your drainage. Enclosed with this letter are one or more maps showing your property in the general vicinity of the Angelina Project and a USDA information release form.

Regarding the maps, we ask that you read the enclosed directions and notate where you know or believe main or lateral tile to be located, along with information such as the condition of the tile, material, width, etc. Where available, the maps already show county repair and maintenance ditches. If you have maps or gps locations of your tile, let us know and we'll arrange a time to review these with you. The USDA information release form is already partially filled out and requires only your name and signature where indicated. This release allows the Soil and Water office to provide Angelina Solar with information regarding any tile/drainage projects on your property. Please sign and send this form to BJ Price at the Preble County Soil and Water Conservation District.
