Teleport Communications America, LLC (Teleport) is filing this supplement to submit its final tariffs in the above mentioned case. Case No. 12-2209-TP-ATC transferred the Certificate of TCG Ohio to Teleport Communications America, LLC.

The tariffs Teleport is filing today will become effective January 1, 2013. As discussed in Exhibit C of 12-2209-TP-ATC TCG is transferring all of its assets to Teleport on December 31, 2012 and will commence providing service on January 1, 2013.

All services provided by TCG will be provided by Teleport as of January 1, 2013. The TCG tariffs should be removed and deleted from your files and website and replaced with the tariffs Teleport is filing today effective January 1, 2013.

**AT&T Comm. PUCO #7 (Access) is replaced by
Teleport PUCO #1 (Access)**

**AT&T Comm. PUCO #8 (Local Exchange Services) is replaced by
Teleport PUCO #2 (Local Exchange Services)**

The tariffs filed today are exactly the same as the TCG tariffs currently on file with the following exceptions.

Teleport PUCO No. 1 Access –

Title Page adds Ashtabula, Knox, Logan, Putnam counties as statewide authority is now automatic
Section 2 Sheets 28.1-28.7 were renumbered 29-35
Section 4 Sheets 7-8 were blank and eliminated
Current Rates Section name was changed to Price List

Teleport PUCO No. 2 Local Exchange Services –

Section 1 Sheet 2 was blank and eliminated
Section 2 Sheet 2 section numbering was changed and subsection names were added – all language remains the same
Section 2 Sheet 37 was blank and eliminated
Section 6 Sheets 5-13 were blank and eliminated
Section 7 Sheets 6-7 and 9-32 were blank and eliminated
Section 10 Sheets 2-6 were blank and eliminated
Price List Sheet 7 was blank and eliminated



The name TCG Ohio is changed to Teleport Communications America, LLC
