APPLICATION OF DOMINION FIELD SERVICES, INC. FOR AUTHORITY TO ABANDON CERTIFICATE

Dominion Field Services, Inc. ("DFS"), pursuant to Rule 4901:1-27-11(B)(1), Ohio Administrative Code ("OAC"), hereby applies to the Commission for authority to abandon Certificate No. 02-044(2) and its operations as a supplier of competitive retail natural gas service ("CRNGS") in this state. A completed Retail Natural Gas Service Supplier/Governmental Aggregator Service Operations and Certificate Abandonment Application is attached. In support of its application, DFS states as follows:

1. DFS is authorized to provide CRNGS service in this state pursuant to renewed Certificate No. 02-044(2), which was issued by the Commission on December 10, 2004. Renewed Certificate No. 02-044(2) will expire on December 5, 2006.

2. Rule 4901:1-27-09, Ohio Administrative Code ("OAC"), requires that applications to renew CRNGS certificates be filed no less than 30 days prior to the certificate's stated expiration date. By this application, DFS, which no longer serves any Ohio customers, is requesting approval to abandon its Ohio operations and certificate pursuant to the provisions of Rule 4901:1-27-11(B), OAC. Accordingly, DFS has not applied for a renewal of Certificate No. 02-044(2).

3. Rule 4901:1-27-11(B)(1), OAC, provides that abandonment applications must be filed at least 90 days before the CRNGS supplier abandons operations. Thus, in Section B-1 of the attached application form, DFS nominally states that DFS will cease operations effective February 5, 2007. However, DFS has no contracts in place with any Ohio customers, and warrants that it will not enter into any contracts with Ohio customers either prior to the expiration of its certificate on December 5, 2006 or thereafter. Because no Ohio customers or natural gas companies will be affected in any way by the abandonment of DFS's certificate, and because Certificate No. 02-044(2), will expire on December 5, 2006 in any event, DFS requests that its abandonment application be granted effective immediately, notwithstanding the 90-day requirement of Rule 4901:1-27-11(B)(1), OAC.

4. The attached application form includes Exhibits C-2 (LDC Notice) and C-4 (Affidavit). However, because DFS no longer serves any customers in Ohio, the information requested in Exhibits C-1 (Notice to Director of the Consumer Services Department) and C-3 (Customer Notice) is not applicable. Thus, those exhibits are not included with the application.

WHEREFORE, Dominion Field Services, Inc. respectfully requests that its application to abandon Certificate No. 02-044(2) be granted.
