

GAS COST RECOVERY RECONCILIATION RIDER

APPLICABILITY

The Gas Cost Recovery (GCR) Reconciliation Rider is applicable to any Customer served under the Rate Schedules identified below.

- Rate 310 – Residential Sales Service
- Rate 315 - Residential Transportation Service
- Rate 320 – General Sales Service
- Rate 325 - General Transportation Service
- Rate 330 - Large General Sales Service
- Rate 340 - Interruptible Sales Service
- Rate 341 - Dual Fuel Sales Service

DESCRIPTION

The GCR Reconciliation Rider shall be applied as an exception to Rule 4901:1-14-05 and Appendix A thereto, to each Ccf of Customer's billed usage each month for the months of December 2006 and January and February 2007 to pass through refunds resulting from PUCO Case Nos. 02-220-GA-GCR and 05-1444-GA-UNC.

The GCR Reconciliation Rider rate shall be applied to all billed Ccf for gas service rendered to Customers served under the applicable Rate Schedules and will be calculated consistent with the formula specified in Rule 4901:1-14-05, Appendix A(B) except that the interest multiplier of 1.01375 shall be substituted for the multiplier of 1.055 specified in the Rule. Any balance hereunder over- or under-refunded to Customers as of the end of February 2007 will be included in the Uncollectible Expense Rider (P.U.C.O. No. 2, Sheet No. 39).

The GCR Reconciliation Rider may be applied in future periods as required to reverse with interest, in whole in or in part, the refunds made to customers served pursuant to the applicable Rate Schedules in the event that the Commission's order in Case No. 02-220-GA-GCR requiring these refunds is overturned.
