
MOTION OF THE STAFF

TO AMEND THE PERIOD OF THE STAFF AUDIT
OF THE SYSTEM RELIABILITY TRACKER (SRT)

The Staff of the Public Utilities Commission of Ohio moves to amend the period included in the Staff audit of System Reliability Tracker (SRT) from the current period of January 1, 2005 through June 30, 2006 to a period including January 1, 2005 through May 31, 2006. Staff so moves to allow the peak demand months of June, July and August to be reviewed and considered together in subsequent audits, which Staff believes will result in a better review of the SRT. Staff has contacted the other parties and none of them objects to this motion.


