ENTRY

The Commission finds:

- (1) Pike Natural Gas Company ("Pike") is a gas or natural gas company and a public utility as defined in Sections 4905.02 and 4905.03(A), Revised Code, and, as such, is subject to the Commission's jurisdiction. On October 13, 2006, Pike filed an application to amend its tariffs to make "housekeeping" corrections to certain sections and to achieve consistency with the tariffs of Pike's sister companies, Eastern Natural Gas Company ("Eastern") and Southeastern Natural Gas Company ("Southeastern"), as follows:

To make housekeeping corrections to Original Sheet No. 5, Original Sheet No. 7, and Original Sheet No. 15.

To amend the "Availability" requirements for the Industrial Service Rate — IS, Original Sheet No. 26, to provide more operational information to customers, to establish certainty for service requirements, and to establish consistent terms and conditions for this service for Pike and its sister companies, Eastern, and Southeastern, for whom companion applications have been filed contemporaneous with this filing.

To amend the "Availability" requirements for the Transportation Service Rate — TS, Original Sheet No. 27, to provide more operational information to customers, to establish certainty for service requirements, and to establish consistent terms and conditions for this service for Pike and its sister companies, Eastern and Southeastern.

- (2) On November 8, 2006, Pike filed a modification to the previously proposed tariff amendments, to correct the inadvertent omission of the Percentage of Income Payment Plan rider's applicability to the Industrial Service.
- (3) The Commission has reviewed the application and finds it to be reasonable and in the public interest. Additionally, the Commission finds that the entire proposed tariff is not for an increase in rates and does not appear to be unjust or unreasonable. Therefore, it is unnecessary to hold a hearing in this matter and the application should be approved.

It is, therefore,

ORDERED, That Pike's application be approved. It is, further,


ORDERED, That Pike be authorized to file complete copies of tariffs in final form consistent with this Entry. Pike shall file one copy in its TRF docket (or may make such filing electronically, as directed in Case No. 06-900-AU-WVR) and one copy in this case docket. It is, further,


ORDERED, That the effective date of the new tariffs shall be a date not earlier than both the date of this Entry and the date upon which final tariffs are filed with the Commission. The new tariffs shall be effective for services rendered on or after such effective date. It is, further,


ORDERED, That this docket be closed of record. It is, further,


