

MidAmerican Energy Company's Unregulated Retail Services gas division has made the decision to discontinue marketing natural gas services in Ohio. Unlike our other gas markets, we've been unable to achieve a scale of business in Ohio that provided acceptable returns on our Ohio gas investment.

The decision to discontinue marketing natural gas services in the Ohio gas market at this time is a unique and independent decision, separate from all other markets, both gas and electric, that we currently serve. We are specifically discontinuing Ohio gas marketing only, and fully intend to remain active in all other markets we currently serve.


MEC Unregulated Retail Services will honor your current agreement and will continue to provide the high quality service you have come to expect for the remainder of the term of the current agreement.

Per the notification requirements of your agreement, we will be providing you with a separate written notice of our intent not to renew or negotiate an extension of your current agreement. Due to our intent to not renew your agreement at the end of the current contract term, we will not execute any additional amendments as they relate to fixed price requests between now and the end of your agreement.

Should you desire to terminate your current agreement prior to the end of the term, you may do so. You will need to provide MEC with a written request at least 30 days prior to the termination date you request. If done so, you may exit the agreement prior to the contract end date with no penalties or settlement amount due.
