This is to certify that the images appearing are an accurate and complete reproduction of a case file document delivered in the regular course of business.

Dear Sirs:

In October of 2005 we had a new furnace installed. Of course one reason was to save on fuel costs, the other was our existing furnace was 29 years old.

For those 29 years I have taken readings and gave them to Columbia Gas with no problems.

On our April 2006 bill Columbia Gas estimated our gas usage of 56 ccf. I read the meter at 7501 with a usage of 36 ccf. Maybe during April I turned the furnace off if we had a warm stretch. Also with the new furnace it has electronic ignition. This is important, because in the summer we always kept the pilot light on the old furnace.

During the 6 warm months Columbia gas April to Sept. calculated gas usage using old furnace values. 20 to 25 ccf. When Columbia Gas read my meter on Sept. 28th they only looked at the last 2 digits 77 using their calculated readings to that point.

My reading is obtained by reading the meter all summer. 7577 there's 7677

On Sept. 28th Columbia Gas replaced my gas meter with one with a sending unit, this lets them read the meter when we are not at home.

During the summer I sent Columbia Gas 2 meter readings, they used their calculations.

When I received the Sept. bill with a reading of 7677 I called customer service and asked them to find my old meter and read it. The next time I called customer service they said they would credit my account 100 ccf. Of course they didn't, that is why I am filing a formal complaint.
