Undersigned counsel for Faruki Ireland & Cox P.L.L. and for Keller and Heckman LLP enter an appearance in this matter on behalf of The Dayton Power and Light Company ("DP&L").

This matter involves a long-standing contractual dispute between DP&L and AT&T Ohio. In its Complaint in this action, AT&T Ohio seeks damages and specific performance under certain agreements between AT&T Ohio and DP&L.
